This document applies for Vitop Hydro taps, in all validated color versions.




Figure 1: Hydro tap.

Taps are made of two components plus the cap.

## 4. TECHNICAL INFORMATION

Vitop Hydro tap fits standard PET 48/40 neck bottle; technical drawing of the finish neck is reported in annex I.

Overall dimensions of Vitop Hydro tap are provided in annex II.

## 5. PACKAGING AND STORAGE SPECIFICATION

Vitop Hydro taps are adequately packed and sent to the customer on pallets of 30 cardboard boxes (400 units per box) with protective adhesive tape (quality Seal).

#### 5.1 Packaging identification

Each cardboard box is identified with a proper label and with an identification code that indicates:

- Vitop's address
- Vitop's article code
- Vitop's SAP code
- Quantity per box
- Production date
- Line number
- Box number
- Traceability code

In order to guarantee a correct traceability system, the identification code must be registered in the daily production records by the customers.

### 5.2 Storage specification

The temperature of the area where the Vitop Hydro taps are stocked shall be room temperature (over 4°C and less than 30°C).


In order to prevent defects to the box/product, no pallet can be put on another one. Vitop also suggests to use FIFO for the stock management.


